8. Resolution - Approving the Appointment of Various Persons as Commissioners of Deeds for 2023/2024.

BY COUNCILOR CALDWELL:

- 9. Application & Agreement To CNY Arts, for the Tier Three Project Support grant in an amount not to exceed \$10,000, funds will be used for the acquisition of new temporary site-specific public art for the Syracuse Public Arts in the Parks program. No local match required.
- 10. Application & Agreement To CNY Arts, for the Regional Arts and Cultural Engagement Program grant, in an amount not to exceed \$5,000, funds will be used for a 12-month Artist in Residence program, to create environmental-based work and to facilitate youth arts programs in our City Parks. No local match required.

Amend Ord. #405 (05/20/2024) "Authorize The 2023/2024 Spirit of Jubilee Stage Project, on behalf of the Department of Parks, Recreation & Youth Programs, for the design, engineering, construction, and installation of a new 36'x22' multi-purpose entertainment stage and pavilion at Spirit of Jubilee Park. All other conditions remain the same.
- 30. The program is designed to promote traffic safety in school zones and will include the installation of photographic monitoring equipment at intersections in or near School Speed Zones in the City of Syracuse, to monitor the failure of vehicles to obey traffic signals and stop at red lights. Vehicle owners will be fined on a perviolation basis, as detailed in the legislation.
- 34. Local Law Of the City of Syracuse authorizing the establishment of an Automated School Speed Zone Enforcement Program in accordance with New York State Vehicle Traffic Law § 1180-f. The program is designed to promote traffic safety and will include the installation of photographic monitoring equipment in School Speed Zones in the City of Syracuse, to monitor for the failure of vehicles to obey posted speed limits. Vehicle owners will be fined on a per-violation basis, as detailed in the legislation.
- 35. Agreement With Onondaga County, relative to the use of the City of Syracuse D.P.W. Fuel Facility, for the period of one year commencing on or about October 14, 2024, with two (2) one-year renewal options, with the approval of the Mayor and the Common Council. Fuel will be charged at the City's cost, including compressed natural gas, plus an additional fee of \$.06 per gallon for maintenance and 5% administrative charge for vehicle key and personnel I.D. numbers, to be deposited in Account #423010.01.
- 36. Agreement With the Syracuse City School District, relative to the use of the City of Syracuse D.P.W. Fuel Facility, for the period of one year commencing on or about October 14, 2024, with two (2) one-year renewal options, with the approval of the Mayor and the Common Council. Fuel will be charged at the City's cost, including compressed natural gas, plus an additional fee of \$.06 per gallon for maintenance and 5% administrative charge for vehicle key and personnel I.D. numbers, to be deposited in Account #549100.01.51320.
